In prior years OneJustice provided administrative support and services to the Legal Aid Association of California (LAAC), a separately incorporated nonprofit. At the end of FY 2013/2014, OneJustice and LAAC mutually agreed to terminate that relationship.

OneJustice also conducted trainings for over 175 participants from 73 legal services nonprofits. OneJustice continued training, consulting services and resources to legal aid nonprofits around the state on topics including leadership, fundraising, strategic planning and governance. OneJustice completed the fifth year of the Executive Fellowship, an intensive 10-month program on nonprofit management and served as the centralized administrator for 11 post-graduate legal fellowships serving individuals facing barriers to employment and veterans.

The award-winning Justice Bus Project organized 39 mobile, pro bono legal clinics serving rural and isolated communities, and the Law Student Pro Bono Project matched 117 law students in the Bay Area and Sacramento with volunteer projects. OneJustice also collaborated with the Association of Pro Bono Counsel (APBCo), law firms and legal services nonprofits to launch two "IMPACT" projects, focused on leveraging pro bono assistance to communities with high need for and limited access to legal services.

Board members and key employees are given a disclosure form each year that asks them to disclose any conflicts, as defined by the policy. The policy also requires any Director who is affiliated with a prospective vendor, paid consultant, or grantee to abstain from voting with regard to any transaction with financial consequences to OneJustice involved that person or entity and, after disclosing his or her interest, to leave the room during discussion and while the vote is taken. At Board meetings, the Chair routinely reminds Board members about the policy and the conflicts requirement before any votes are taken involving transactions with financial consequences to OneJustice. The minutes reflect the Board's actions were in compliance with the policy when any such votes are taken.
