OneJustice's Healthy Nonprofits program provides training, coaching, and consulting to boards, executives, and senior management of legal services organizations throughout California to build the leadership and management skills they need to survive and thrive in the increasingly complex nonprofit sector. During Fiscal Year ("FY") 1819, OneJustice provided brief technical assistance on nonprofit management in 101 cases to 27 unique legal services nonprofits, and provided in-depth consulting in 106 cases to 46 unique organizations. OneJustice also conducted 26 trainings for over 700 attendees from organizations throughout the state. OneJustice completed the ninth year of the Executive Fellowship project, an intensive 10-month program on

OneJustice's Pro Bono Justice program expands volunteerism in the legal community, providing strategic planning, training, coaching, and resources to legal services nonprofits, firms, schools, and corporations on how to design and administer highly successful volunteer ("pro bono") legal projects. OneJustice also develops innovative pro bono delivery models, including focusing on the needs of rural Californians. During FY 1819, the Pro Bono Justice program brought together nonprofit and law firm pro bono leaders at the 2019 California Statewide Pro Bono Conference in Los Angeles, attended by 127 leaders in pro bono management from law firms, corporations, law schools, and legal services nonprofits. OneJustice also continued to

nonprofit leadership and management, with 21 Fellows graduating in May 2019. OneJustice also coordinated for the final time the annual Northern California Public Interest/Public Sector Careers Day, one of the largest public interest and government career fairs in the nation. The 2019 Careers Day was attended by 152 employers and more than 600 law students.

The Healthy Nonprofits Program launched a new project called the Organizational Change Accelerators in FY 1819, which is a capacity-building fellowship program that provides training and coaching in three specific content areas that are critical to increasing the efficiency and effectiveness of legal services organizations: Research and Evaluation, Pro Bono, and Innovation. During FY 1819, we enrolled staff from 18 organizations in the three fellowships. A second new project launched in FY 1819 is called the Capacity Building Academy, which aims to increase the capacity of legal services organizations serving rural immigrant communities through an online training program. We enrolled and taught 3 cohorts of legal services staff (2 cohorts focused on healthy nonprofits topics and one cohort focused on pro bono best practices), iterated the curricula to incorporate participant feedback from the pilot cohorts, and connected 6 organizations with pro bono transactional support.

In FY 1819, the Healthy Nonprofits Program's Californians for Legal Aid project supported public policies that increase access to legal

services for low-income Californians in the following ways: staff met with the offices of 24 of California's federal Members of Congress in Washington, DC, to educate them about the services that legal aid programs provide to constituents in their districts and urged their support for increased federal funding for legal aid; mobilized the Californians for Legal Aid network on the federal appropriations process for Legal Services Corporation funding, authored multiple policy advocacy letters, and hired a full-time Fellow to the Californians for Legal Aid team.

staff and convene the Northern California and Southern California Pro Bono Managers groups. OneJustice's award-winning Justice Bus Project engaged over 575 volunteers to deliver 48 mobile legal clinics, serving low-income people in rural and isolated areas of the state. One new aspect of the Justice Bus Project in FY 1819 was the first-ever Justice Plane trip, which took place in San Luis Obispo and Paso Robles over two days. The Bay Area and Los Angeles Association of Pro Bono Counsel (APBCo) IMPACT Projects engaged over 165 pro bono volunteers to deliver 24 free legal clinics in isolated communities in the San Francisco Bay Area and south Los Angeles. These Justice Bus Project and IMPACT legal clinics primarily assisted low-income Californians with immigration and criminal record clearance services. OneJustice also continued its work in the collaborative "California Pro Bono Training Institute" project to develop 55 new training video modules, and 23 revamped modules, which were used by volunteers throughout the state to prepare for their participation in pro bono opportunities.

In FY 1819, the Pro Bono Justice team provided in-depth impact evaluation consulting services and infrastructure development for the Marin Pro Bono Network. In addition, in Northern California, the Pro Bono Justice team began hosting an Equal Justice Works Fellow focused on developing clinic models that address the intersection of immigrant rights and criminal justice. In Southern California, OneJustice staff continued to support affirmative immigration services providers and pro bono programs both regionally and statewide, which included developing "Pro Bono Training Institute" trainings on immigration and hosting a Pro Bono Best Practices workshop series.

The policy also requires any Director who is affiliated with a prospective vendor, paid consultant, or grantee to abstain from voting with regard to any transaction with financial consequences to OneJustice involved that person or entity and, after disclosing his or her interest, to leave the

room during discussion and while the vote is taken. At Board meetings, the Chair routinely reminds Board members about the policy and the conflicts requirement before any votes are taken involving transactions with financial consequences to OneJustice. The minutes reflect the Board's actions were in compliance with the policy when any such votes are taken.

Form 990, Part VI, Section B, Line 15a:

The OneJustice Board delegated to its Executive Committee the review of executive compensation. Upon assessing the Executive Director's compensation in June 2017, the Committee consisted of the Board Chair, Vice Chair, Immediate Past Chair, and Secretary, all of whom are independent persons. The CEO was not involved in the compensation review and approval process.

In its evaluation, the Executive Committee reviewed comparable executive compensation packages in the broader nonprofit sector, as well as the legal services nonprofit sector more specifically. The Committee reviewed comparability data from several sources including, but not limited to, the OneJustice salary scale approved by the Board of Directors, the 2016 Legal Aid Compensation Survey Report, and the 2018 Northern California Fair Pay Nonprofit Compensation report. The Board reaffirmed the Committee's determinations about executive compensation when it approved the organization's budget for FY 1819 in June 2018. Additionally, the Board will continue to meet periodically to assess whether the Executive Director's pay continues to abide by market standards.
