## A MESSAGE FROM PHIL

Legal aid is often about what matters most in life. More than 25 years have passed, and I still remember my first clients:

The couple who had HIV and couldn't get their landlord to fix the heat or make repairs, which was endangering their lives.

The father who was recovering from addiction, living with HIV, and wanted visitation rights with his children. He wanted to spend whatever time he had left with his children.

Having access to legal aid meant the world to them. Over 500,000 individuals each year receive essential help from the legal organizations and volunteers supported by OneJustice.

Throughout the global pandemic, the legal aid and pro bono community has adapted, innovated, and improved how legal services are delivered, with OneJustice's support.

Together, we have provided hope to neighbors at risk of becoming homeless, survivors of domestic violence, and families in rural and isolated communities.



## EXECUTIVE FELLOWSHIP

One Justice completed the twelfth year of its Executive Fellowship program, an intensive 10-month program on nonprofit leadership and management. One Justice trained leaders from 28 legal services organizations in California, Georgia, New Jersey, New York, and Washington state. 50% of these leaders identified as BIPOC and/or LGBTQIA+. We are grateful to The Bigglesworth Family Foundation for its generous support of the Executive Fellowship Program.

### HEALTHY NONPROFITS PROGRAM

One Justice also provided in-depth support to many of California's largest legal aid organizations, assisting leaders statewide with management issues and sharing of best practices. In addition, One Justice offered programming to legal services organizations across California on essential topics, such as effective data practices in homelessness prevention, program evaluation, budgeting and financial management, advancing equity in board leadership, and leadership succession planning.

## PROBONO JUSTICE PROGRAM

One Justice brought together more than 60 legal aid organizations, law firms and corporations to address emerging needs, highlight successful pro bono models, and strategize on the effective management and strategic deployment of volunteer resources. This included One Justice's annual Pro Bono Conference, webinars, and strategy meetings throughout the year, which addressed topics such as language justice and pro bono, housing pro bono opportunities, legal name change and gender marker change clinics, and hybrid pro bono work.

Through its Pro Bono Training Institute, One-Justice trained over 2,000 individuals from law firms, legal aid organizations, law schools, and universities on critical legal topics, including housing, asylum, and disaster relief. Since its inception, the Pro Bono Training Institute has published 169 training modules spanning 28 topics.

## **SPOTLIGHT**

## Small Claims/Back Rent Toolkit & Court Watch Project


"This project's impact on families was inspiring and encouraging..."

During the COVID-19 pandemic, many low-income families were faced with job and wage losses and unable to pay their rent. These families have had to defend themselves in small claims court against unfair rental debt collection, and often are unfamiliar with the court system or their legal defenses. They are at a disadvantage, in danger of becoming homeless, and risk falling into long-term debt.

In response to the crisis, One-Justice created a Small Claims/Back Rent Toolkit, which has been used by legal programs, Small Claims Bench Officers, Self Help Centers, law schools and CBOs from 102 cities. Legal services organizations across the state are using the toolkit to expand their services to families facing rental debt. The Toolkit is free and available to anyone in the legal aid community who needs it.

In 2022, One-Justice launched the Court Watch Project and trained volunteers to gather information on how Small Claims Courts administered new COVID-19 rental debt laws and procedures. Volunteers collected information on COVID-19 rental debt cases and conducted 590 court observations throughout the state. One-Justice's Court Watch toolkit is available for advocates who seek to launch a Court Watch project in their own communities.

## NUMBERS & IMPACT

OneJustice offers training and support to legal services organizations and volunteers that help more than 500,000 individuals per year.

### **Community = Collective Power**

One Justice convenes the legal services sector to harness the wisdom, resources, and ingenuity of dedicated legal nonprofits and advocacy groups, pro bono partners, law schools, and courts to creating real meaningful change.

We use this community building strategy to create a collaborative analysis of systemic trends and case studies, and then create tools that translate into impact for all stakeholders.



## **ADVOCACY**



One Justice advocates for increased funding for civil legal aid in California.

Every year, hundreds of thousands of low-income Californians need legal services to stay in their homes, access health care, escape abuse, and provide for basic necessities. Because of inability to pay, many of these residents would go without legal assistance if not for high-quality pro bono legal aid programs funded in part by federal and state dollars.

During ABA's Advocacy Week in 2022, One Justice advocated with California's 2 U.S. Senators and 19 Representatives for an increase in federal legal aid funding. In December 2022, President Biden signed legislation that included \$560 million for the Legal Services Corporation, a \$71 million increase over the prior year.

## MAXIMIZING THE IMPACT OF LEGAL SERVICES

### **Maximizing Impact:**

Homelessness Prevention, Consumer Debt, and Immigration

Our tools of change are at the heart of new projects to help legal services organizations and their pro bono partners deepen and broaden their impact on individuals, families, and communities.

One Justice will be offering new trainings to maximize the impact of legal services in the areas of homelessness prevention, consumer debt, and immigration. Our focus will be on using data to guide decision-making, implementing the most promising and effective practices, and improving long-term outcomes.


## FY2022 FINANCIALS
