# Program Highlights

## **CONSUMER PROTECTION**

Consumer debt cases are the most difficult for low-income Americans to bounce back from. OneJustice provides critical support to advocates across the state. We are helping to make consumer protections for lowincome families more accessible and impactful in their lives.

#### IMMIGRATION LEGAL SERVICES

OneJustice's new training program helps legal aid nonprofits and volunteers maximize their impact on immigrant families across California, including in the Central Valley, Central Coast, Bay Area, Greater Los Angeles Area, and Inland Empire.



#### **MOVEMENT LAWYERING**

Legal aid is partnering with clients, activists, and community organizations to create systemic change, with OneJustice's support. Legal aid advocates and law students are learning how they can support social movements through OneJustice's Movement Lawyering Project.

## **RURAL JUSTICE**

Rural communities have few legal services providers. OneJustice partners with rural legal aid programs to improve access to services and increase pro bono support of rural communities.

Individuals threatened with eviction often end up defending themselves in court unfamiliar with the legal system and unaware of their rights.

# **SPOTLIGHT** Homelessness Prevention Program

#### Expertise

With deep working knowledge, we share best practices and consult with legal aid programs on reducing homelessness. This past year, OneJustice shared its expertise at a national conference, encouraging legal aid programs to leverage technology and volunteers to uncover inequities in the courts and improve systemic outcomes.

#### **Innovation**

OneJustice is guiding housing legal aid providers on how to maximize their impact through collaborative pro bono partnerships and AI & technological tools.


